This Amendment No. 3 to the MEMORANDUM OF UNDERSTANDING ("MOU") is entered into as of the last date opposite the respective signatures by and between the COUNTY OF MONTEREY, a political subdivision of the State of California ("COUNTY"), and the MONTEREY REGIONAL WASTE MANAGEMENT DISTRICT DBA REGEN MONTEREY ("MRWMD"), a public agency, (collectively referred to as "Parties"), with reference to the following facts:

RECITALS

WHEREAS, the Parties have heretofore entered into the MOU dated October 8, 2020 for COUNTY administration of a Litter Abatement Program ("Program") to collect waste and mitigate illegal dumping throughout the County;

WHEREAS, MOU was amended by the Parties on July 13, 2021 (hereinafter, "Amendment No. 1") to extend the term for two (2) additional years through June 30, 2023 to allow the Program to continue using existing available funding;

WHEREAS, MOU was amended by the Parties on June 8, 2023 (hereinafter, "Amendment No. 2") to extend the term for two (2) additional years through June 30, 2025 to allow the Program to continue using existing available funding; and

WHEREAS, the Parties wish to amend the MOU to extend the term for one (1) additional year from the current expiration date, through June 30, 2026 to allow the Program to continue using existing available funding.

1. Amend the first sentence of Section 1, Effective Date and Term, to read as follows:

This MOU is effective October 8, 2020 and shall remain in force through June 30, 2026 unless earlier terminated as provided in this MOU.

2. Except as provided herein, all remaining terms, conditions, and provisions of the MOU are unchanged and unaffected by this Amendment and shall remain in full force and effect as set forth in the MOU.
